

COVID-19 JOBSITE HEALTH AND SAFETY RULES & REGULATIONS

- 1. TO ALL PERSONS ENTERING THE JOBSITE, <u>YOU MUST AT ALL TIMES</u>:
 - a) SANTIZE YOUR HANDS UPON ENTRANCE & EXIT OF JOBSITE
 - b) BE WEARING PROPER <u>PPE</u> FOR AIRBORNE ILLNESSES. CONTRACTORS ARE EXPECTED TO ARRIVE WITH THEIR OWN PPE.
 - I. FACEMASK

Minimum standards:

- a. fit snugly but comfortably against the side of the face
- b. be secured with ties or ear loops
- c. include multiple layers of fabric
- d. allow for breathing without restriction
- e. be able to be laundered and machine dried without damage or change to shape
- II. PROTECTIVE EYEWEAR I.E. GOGGLES OR SAFETY GLASSES
- III. DISPOSABLE GLOVES, OR CONTRUCTION GRADE GLOVES AS APPLICABLE
 - I. Be sure to sanitize hands AND gloves
- 2. MAINTAIN <u>SIX FEET APART</u> FROM OTHER PERSONS AT <u>ALL TIMES</u> UNLESS NECESSARY TO COMPLETE TASK. IF NECESSARY, LIMIT TO TWO PERSONS IF POSSIBLE

COVID-19 JOBSITE HEALTH AND SAFETY RULES & REGULATIONS (CONTINUED)

- 3. BE SURE TO BE CARRYING **YOUR OWN TOOLS** AS NEEDED FOR YOUR SCOPE
 - a) If tools must be shared, be sure to sanitize before and after shared use
 - b) RS Company has EPA registered disinfecting spray available that can be used on shared tools and high contact surfaces
 - i. To be applied at beginning of breaks and/or at end of day the product needs 10 minutes to settle
- 4. BE SURE THAT INDIVIDUALS TAKE STAGGERED <u>BREAKS AND LUNCHES</u> NO PERSONS SHOULD BE GATHERED AT ANY TIME
- 5. BRING <u>LUNCH & SNACKS</u> TO JOBSITE AT <u>START OF THE DAY</u> IN ORDER TO AVOID CONTAMINATION



COVID-19 JOBSITE HEALTH AND SAFETY RULES & REGULATIONS (CONTINUED)

6. STANDARD HEALTH & SAFETY PROCEDURES:

- i. Do not touch your face with unwashed hands or with gloves.
- ii. Frequently wash your hands with soap and water for at least 20 seconds or use hand sanitizer with at least 60% alcohol.
- iii. Clean and disinfect frequently touched objects and surfaces such as work stations, keyboards, telephones, handrails, machines, shared tools, elevator control buttons, and doorknobs.
- iv. Cover your mouth and nose when coughing or sneezing, or cough or sneeze into the crook of your arm at your elbow/sleeve.
- v. Do not enter the jobsite if you have a fever, cough, or other COVID-19 symptoms. If you feel sick, or have been exposed to anyone who is sick, stay at home.
- vi. Constantly observe your work distances in relation to other staff. Maintain the recommended minimum six feet at all times when not wearing the necessary PPE for working in close proximity to another person.
- vii. Do not carpool to and from the jobsite with anyone except members of your own household unit, or as necessary for workers who have no alternative means of transportation.
- viii. Do not share phones or PPE.

SIGN-IN PROCEDURES

BEFORE ENTERING THE JOBSITE, ALL PERSONS MUST SIGN IN BY THE FOLLOWING PROCEDURES:

- 1. TEXT THE PROJECT SUPERINTENDENT LISTING THE BELOW:
 - FULL NAME
 - COMPANY
 - TEMPATURE
 - SEE FOREHEAD THERMOMETER PROVIDED BY RS COMPANY
 - TEMPERATURE SHOULD BE WITHIN THE RANGE OF 97°F (36.1°C) to 99°F (37.2°C)
 - IF YOUR TEMPERATURE IS HIGHER THAN 99°F (37.2°C), RETURN HOME AND SEEK MEDICAL ATTENTION
 - DO YOU HAVE ON YOUR APPROPRIATE PPE? MASK, GLOVES, EYEWEAR (Y/N)
 - IN THE LAST 24 HOURS, HAVE YOU EXPIRIENCED ANY OF THE FOLLOWING SYMPTOMS? (Y/N) IF YES, PLEASE RETURN HOME NOW.
 - CHEST PAIN
 - COUGH
 - SHORTNESS OF BREATH
 - ANY FLU-LIKE SYMPTOMS
 - BEEN IN CONTACT WITH ANYONE WHO IS SICK

FREQUENTLY ASKED QUESTIONS

What kind of spaces can we treat?

• Tenant spaces, Building Common Areas, Restrooms, Elevators, Parking Garages

Where is this product applied:

- This is applied as fogging treatment. It is misted throughout the spaces, coating all surfaces (floors, ceilings, working surfaces, etc.)
- Product data sheets & video of application process available upon request

Does this product leave any residue, or cause any damage to surfaces?

- We tested this product on our own office. After drying, there is not any residue left to the touch. Although, food prep surfaces (breakroom counters, tables, etc.) must be cleaned after treatment. In addition, glass windows are left looking slightly foggy. It would be best to have glass surfaces cleaned by your janitorial service after our application.
- In treating our office, the product was tested on clear finished solid wood, quartz, LVT, carpet, ceiling tile, ceramic tile, glass, and stainless appliances & hardware. None of the surfaces were stained. Before spraying, receptacles, smoke detectors, electronics (monitors, hard drives, copiers, etc.), and artwork will be protected. Any paper products that the client does not want exposed will need to be stowed away.
- The product has a mild fresh linen scent. After the product has settled, there should be little to no scent. If smell is a concern, we can place HEPA filtered air scrubbers once the product has settled.

FREQUENTLY ASKED QUESTIONS (CONTINUED)

How long does the work take?

- For example, a 2,000 SF space took 1 hour between protection, spraying, window cleaning & clean up.
- The product needs 10 minutes to dry, and will need to settle for at least four hours before any persons enter the space.

What is the cost?
